Bidders will be expected to remove any unusable/worn-out/dilapidated LAN infrastructure to facilitate the new installations. We however wish to note that very few areas will require removal of the unusable/worn-out/dilapidated LAN infrastructure, thus minimal, if any, associated labour costs. In the event a service provider finds the removal of this material resulting in significant costs, The Judiciary will undertake the removal process on their behalf.

Question 6

Response 6

Question 7

When submitting a bid for two lots, should one submit one proposal or two separate proposals?

Response 7

The bidder will be required to submit a combined proposal as one bid. However, and as captured in the Form of Tender, the bidder will be required to indicate the bid amount for each lot separately.

Question 8

If a bidder wishes to undertake site visits outside the site visit schedule, can they be facilitated?

Response 8

Yes, the bidders will be facilitated. However, you are required to request for the facilitation in writing, at least 24 hours before the intended visit date. The Authority will respond to your request with further directions.
