You may use this form to apply for an Amateur Radio (Foundation, Intermediate, Club, Temporary or Full licence).

C: General Information

Please note that if you have successfully passed the radio amateur examinations for the respective radio licence category i.e. Foundation, Intermediate, Club, Temporary or Full licence, you are encouraged to apply for the Amateur radio licence on the CA website:

D: The application shall be submitted with the following: -

- 1. For Kenyan applicants,
 - 1.1 A sworn affidavit by a commissioner for oaths of clear copies of the following documents;
 - a) Kenyan National Identity Cards or Kenyan passports of the applicant.
 - b) Both sides of the ID should be copied onto the same side of an A4 size paper.
 - c) Passports copies should include pages showing the date of issue and expiry, holders name, photograph.

2. For Foreign applicants,

- 2.1 Clear copies of the following documents notarised by a Notary public;
 - a) Valid passport of the applicant.
 - b) Passports copies should include pages showing the nationality, date of issue and expiry, holders name, photograph and Kenyan Visa for foreigners.
- 3. Certificate of a recognized Radio Amateur Examination or ₁ valid and current licence.

5. The Authority does not accept cash payments for Amateur fees, please use the mobile cash payments or bank transfers.

E. Information for new applicants

- To be eligible for an Amateur Radio (full) Licence you must:
- Have passed and been issued with Harmonized Amateur Radio Examination Certificate (HAREC) or its equivalent.

To be eligible for an Amateur Radio (Intermediate) Licence you must have passed the intermediate examination.

To be eligible for an Amateur Radio (Foundation) Licence you must have passed the foundation examination.

To be eligible for an Amateur Radio Club Licence you must:

- Already have an Amateur Radio Licence; and
- Submit details of two club members (excluding the applicant), each of whom must also hold an Amateur Radio Licence.
- The applicant shall be responsible for the licence and operation of the equipment.

To be eligible for a Temporary Licence:

• The applicant should meet Kenyan licence qualifications and standards.
